

## **Child and Adolescent Psychiatrist**

The Massachusetts General Hospital Department of Psychiatry invites child and adolescent psychiatrist applicants for a part-time position in the Resilience Evaluation-Social Emotional Training (RE-SET) program, a clinical high-risk for psychosis program, within the Psychosis Clinical and Research Program. The psychiatrist position would involve evaluating and treating patients (including children and adolescents from ages 10-17 and adults ages 18+) with concerns for attenuated or early psychosis. The psychiatrist would be Co-Medical Director of the RE-SET program in collaboration with the RE-SET clinical director (psychologist) and current Medical Director. The position is to begin in between January 2024 to July 2024, pending credentialing and insurance empanelment.

The position includes 0.2-0.5 FTE in the RE-SET program. Additional FTE in the First Episode and Early Psychosis Program (FEPP) treating individuals early in the course of a non-affective psychotic disorder is available if desired. The RE-SET program conducts diagnostic clinical consultations and provides ongoing treatment for patients at clinical high-risk for psychosis. The interdisciplinary program provides individual therapy, group therapy, family therapy, psychopharmacology, and school and employment support. The psychiatrist role would be to perform diagnostic evaluation and psychopharmacology consultation and treatment in the program. The PCRP's programs aim to address psychological, psychosocial, environmental, age-specific issues in a culturally-responsive manner to maximize emotional, social, and physical well-being. Within the PCRP and affiliated programs, there are opportunities to supervise and participate in clinical research.

The PCRP invites applicants qualified for an academic appointment at Harvard Medical School at the rank of Instructor, Part-time, or Assistant Professor, Part-time. Applicants who work well in teams, collaborate well with colleagues, thrive in a fast-paced work environment, and enjoy engaging in clinical interventions, evaluation, consultation, and supervision of trainees will be particularly well-suited for this work. Additionally, RE-SET is part of a state-wide consortium of clinical high-risk for psychosis programs and applicants who are interested in collaborative clinical, administrative, and research work, are encouraged to apply.

Applicants must have an M.D., D.O, or equivalent doctoral degree in Medicine, have completed an adult psychiatry residency and child and adolescent psychiatry fellowship. Applicants must have an active Massachusetts medical license or be eligible to obtain one, be board-certified or board-eligible in adult psychiatry and child and adolescent psychiatry and have an active DEA license. Applicants should have experience or interest in working with individuals with early psychosis.
